

ANNOUNCEMENT NO. 7
of the Rector of West Pomeranian University of Technology in
Szczecin
of 12 February 2024

on fees for accommodation in WPUT student houses

Under § 2 section 3 of Directive no. 89 of WPUT Rector dated 1 July 2022 on Rules of payment for the use of the student residences of West Pomeranian University of Technology in Szczecin (as amended) it is hereby directed as follows):

1. Daily fees for accommodation in student houses (DS) **as of 1 March 2024:**

- 1) Monthly fees for WPUT students and PhD students or students and PhD students of other universities (provided that accommodation agreement between universities has been signed):

- 2) Monthly fees (VAT included) for students and PhD students of other universities (if accommodation agreement between the universities has not been signed), participants of postgraduate studies and students in post-secondary schools, school children, and spouses of the students and PhD students (not students themselves) of other universities.

- 3) In the event of a person illegally staying overnight in the DS, a daily fee is charged in the amount of:
 - a) WPUT students and PhD students 70,00 PLN
 - b) other persons (VAT included) 80,00 PLN
 - 4) a daily fee for a guest staying overnight in the room of a person residing in the DS:
 - a) WPUT students and PhD students 30,00 PLN
 - b) other persons (VAT included) 40,00 PLN
 - 5) in the event of failure to settle the accommodation balance with the administration of the student house in question in line with the provisions of the applicable regulations, a daily fee shall be:
 - a) 200 PLN – for a room,
 - b) 150 PLN – for a bathroom,
 - c) 350 PLN – for a room with a bathroom,
 - d) 200 PLN– per bathroom in a dormitory cubicle.
2. A person who is not a ZUT student or doctoral student, who was assigned a place in the student hostel, shall receive free of charge an access card to entrances covered by the electronic system. Issuing a duplicate of the card shall be subject to fee of 40.00 zlotys (including VAT).
 3. As of 29th February 2024, the Announcement no. 26 of the Rector of ZUT of 10th August 2023 on the Fees for Using Student Hostels of the West Pomeranian University of Technology in Szczecin, including the amendment introduced in the Announcement no. 46 of the Rector of ZUT of 12th December 2023, shall cease to be effective.
