ORDER NO. 19

of the Rector of West Pomeranian University of Technology in Szczecin of 11th February 2025

amending the Order no. 104 of the Rector of ZUT of 20th September 2021

concerning the Regulations of the Halls of Residence

of the West Pomeranian University of Technology in Szczecin

Basing on art. 23 in relation with art. 11 par. 5 of the Act of 20th July 2018 on the Law of Higher Education and Science (unified text: Journal of Laws item 1571, as amended), in agreement with the Students Council, it is ordered as followed:

§ 1.

The following changes shall be introduced in the Regulations of the Halls of Residence of the West Pomeranian University of Technology in Szczecin, which is an appendix to the Order no. 104 of the Rector of ZUT of 20th September 2021 concerning the Regulations of ZUT Halls of Residence (as amended):

- 1) section 8 shall be added in § 9 section 7:
 - "8. A stay of a student with a dog is allowed under the following conditions:
 - such a stay is only possible at DS Amicus for students of Cynology at the Faculty of Biotechnology and Animal Husbandry of ZUT. A student interested in a stay with a dog shall be obligated to obtain a permit of the Manager of DS Amicus, 7 days prior to the check-in;
 - 2) rooms dedicated to living with a dog shall be indicated by the Manager of DS Amicus;
 - 3) living with a dog in a double room shall only be possible if it is taken for the single use;
 - 4) a stay with a dog shall entail an additional fee determined in the Announcement of the Rector on the Rates for Using Halls of Residence;
 - 5) the administration of the ZUT hall of residence shall make signs on the doors of room where living with a dog has been applied;
 - 6) a stay of a disabled student with a guide dog shall be free of charge. The limitation stipulated in item 1 shall not apply to a student with disability who would like to live in the hall of residence with a guide dog;
 - 7) a student who owns a dog shall be obligated to have the dog's health book with information on current vaccination of the animal. The document should be presented at each request of a hall of residence employee;
 - 8) a student who owns a dog shall be responsible for keeping silence and not disturbing the peace of other residents of the hall of residence;
 - 9) there is an obligation to use a collar, a lead, and a muzzle on the premises of the ZUT student housing complex (including DS Amicus);
 - 10) a student who owns a dog shall be obligated to provide an independent, appropriate place for the dog to sleep in the room. It is forbidden to use beds for that purpose;

- 11) the hall of residence administration may refuse to accept dogs of breeds listed as aggressive provided in § 1 of the Order of the Minister of Internal Affairs and Administration of 28th April 2003 on the List of Dog Breeds Assumed as Aggressive (Journal of Laws no. 77, item 687);
- 12) in order to fulfil physiological needs, dogs should be taken outside the ZUT student housing complex; a student who owns a dog shall be obligated to clean the waste left by the animal;
- 13) a student who owns a dog shall bear full responsibility for damages made to another person or university property related to the stay of a dog;
- 14) a student who owns a dog shall be obligated to wash the upholstered furniture and disinfect the room when the stay finishes. If the above obligation is not fulfilled, the hall of residence administration shall commission the washing and disinfection and shall charge the student in accordance with the Rector's announcement."
- 2) section 1 item 11 in § 11 shall state:

"11) possession and keeping animals, with reservation of § 9 section 8."

3) section 1 in § 13a shall state:

"1. The Manager of the hall of residence shall have the right to warn a resident in case of violating the provisions stipulated in Chapter IV and also in case of the failure to keep the obligation provided in § 8 section 2 item 7), with the result stipulated in § 17 section 2a."

§ 2.

The Order shall come into force on the day of signing, effective from 17th February 2025.
