

**Communication No. 34**  
**of the Rector of the West Pomeranian University of Technology in Szczecin**  
**of September 12, 2022**  
**on accommodation fees for the use of halls of residence**  
**of the West Pomeranian University of Technology in Szczecin**

Based on § 2, paragraph 3 of the Order No. 89 of the Rector of the West Pomeranian University of Technology (Polish acronym: ZUT) of July 1, 2022 on the Principles of payment for the use of student halls of residence of the West Pomeranian University of Technology:

1. The amounts of fees for the use of WPUT (ZUT) student halls of residence (Polish abbreviation: DS) **valid from October 1, 2022** are established:
  - 1) the amount of monthly fees for students and PhD students of WPUT (ZUT) and students and PhD students of other universities (in case of signing an accommodation agreement between respective universities):

- 2) the amount of monthly fees (including VAT) for students and PhD students of other universities (in the event that a contract for accommodation is not signed between WPUT and these universities), participants of postgraduate studies, students of post-secondary schools, pupils, spouses (who are not students) of students and PhD students of WPUT and spouses (who are not students) of students and PhD students of other universities:

3) in the case of persons staying overnight illegally in a hall of residence, a daily fee is charged in the amount of:

a) for students and PhD students of WPUT (ZUT) PLN 70.00

b) for other persons (the fee includes VAT) PLN 80.00

4) the daily fee for guests staying overnight in resident's room of HR (DS) is:

a) for students and doctoral students of WPUT PLN 30.00

b) for other persons (VAT included) PLN 40.00

5) the amount of the fee in the case of failure to settle the accommodation with the administration of a given student halls of residence in accordance with the provisions of the Regulations in force:

a) PLN 70 - per room,

b) PLN 50 - for a bathroom,

c) PLN 120 - for a room with a bathroom,

d) PLN 70 - for a bathroom in a dormitory unit.

2. Starting from September 30, 2022 Communication No. 7 of the Rector of West Pomeranian University of Technology in Szczecin of February 24, 2022 on the fees for the use of student halls of residence of the West Pomeranian University of Technology in Szczecin loses its legal validity.
